

### **Prize Draw Terms and Conditions**

The prize draw is organised by ResMed (UK) Limited (Company No. 02863553), Quad 1, First Floor, Becquerel Avenue, Harwell Campus, Didcot, OX11 0RA, United Kingdom (the “Promoter”).

#### **1. Eligibility**

- 1.1. The prize draw is open to all UK residents aged 18 years or over, except employees of the Promoter, their families, agents or anyone else connected with the conception and implementation of the prize draw.
- 1.2. In addition, the Promoter reserve the right, at its sole discretion, to exclude persons from participation if there are reasonable grounds for doing so, for example:
  - a) In the event of manipulation in connection with access to or implementation of the prize draw;
  - b) In the event of breaches of these terms and conditions of participation;
  - c) In the event of false or misleading information in connection participation in the prize draw.

#### **2. Entry Conditions**

- 2.1. The prize draw is free to enter, and no purchase is necessary. Entrants can participate in the prize draw via an online form on the landing page on [resmed.co.uk/tackle-your-sleep/](https://resmed.co.uk/tackle-your-sleep/). Only one entry per person is permitted.
- 2.2. The opening date for entries is 9<sup>th</sup> of June 2025. The closing date of the prize draw is midnight on 2<sup>nd</sup> of August 2025. Entries received after this date will not be considered.
- 2.3. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
- 2.4. Participants are deemed to have accepted and agreed to be bound by these prize draw terms and conditions upon entry. The Promoter reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.

#### **3. Winner Selection and the Prize**

- 3.1. There are eleven prizes in total, where these eleven winners will be chosen by random draw performed by a computer process on 4<sup>th</sup> August 2025 (“Draw Date”) from all eligible entries after the competition has closed.
- 3.2. Ten winners will each receive 1 official rugby ball, branded with ResMed logo.
- 3.3. One winner will receive 1 official British & Irish Lions T-Shirt signed by multiple players. For clarification, the Promoter does not guarantee it will be signed by all players.

- 3.4. The Promoter reserves the right to hold, void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

#### **4. Winner Notification and Prize Delivery**

- 4.1. The winners will be notified by email (using details provided at entry). Winner must claim their prize within thirty (30) days of notification. If a winner does not claim their prize within this period, then the winner's prize will be forfeited, and the Promoter reserves the right to select another winner in accordance with the process described above.
- 4.2. The above-mentioned prizes will be sent free of charge to a UK address provided by each winner within fourteen (14) days of each winner responding to the Promoter from the date of notifications.
- 4.3. The decision of the Promoter regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
- 4.4. The prize for the winner is non-exchangeable, non-transferable and no cash-alternative is offered.
- 4.5. While the Promoter will take reasonable steps to ensure safe delivery of the prizes, the Promoter accepts no responsibility for any prizes that are lost, delayed, stolen or damaged in transit, or for any failure of delivery due to incorrect or incomplete address information supplied by the winner or for any failure or delay in delivery due to circumstances that are beyond the Promoter's reasonable control (including but not limited to, strikes, supply shortages, adverse weather, or any similar reasons).
- 4.6. No replacement or alternative prize (including cash or compensation) will be offered in the event that a prize is lost or damaged after it has been despatched.
- 4.7. - 6.1. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winners or accept any liability for any loss, damage, personal

injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
